2021 Haunted Forest Volunteer Information






- Volunteers agree to work from 5 pm until 10:30 pm on Saturday, October 16th, 2021 and understand that late arrivals and early departures cannot be accommodated unless arrangements are made with Camp Fire Camp Toccoa before Wednesday, October 13th.
- Some volunteer groups may be asked to have an adult chaperone.
- Volunteers are not to bring children with them to volunteer or be an activate participant in the event.
- Jobs will include, but are not limited to, passing out candy, running carnival games, managing parking, tending to a campfire and tear down. Jobs will be assigned by Camp Fire staff based on the number of volunteers, the needs of Camp Fire Georgia, skill sets and more; we will do our best to place each volunteer in a position that is comfortable for them.
- Dinner will not be provided, please prepare accordingly and bring snacks as needed.
- Volunteers are asked to remain at their assignment until relieved by another assigned volunteer or Camp Fire staff personnel. Camp Fire staff will do our best to give each volunteer a short break to enjoy Haunted Forest.
- Haunted Forest will take place outdoors, please dress accordingly. Volunteers may dress up if they desire. Tennis or other sturdy shoes are required; please no sandals, flip flops, Chacos, or any other open shoes, etc. Clothing or tattoos with offensive language or graphics are not permitted at any time.
- Haunted Forest is a family event. We expect volunteers to behave appropriately.
 Volunteers must refrain from the use of abusive language, symbols or gestures.
- Smoking is not permitted on Camp Fire Camp Toccoa property.
- Violent or inappropriate sexual behavior toward camp staff, volunteers, or any other individual will be grounds for dismissal. Participants who use blogs or personal web sites to harass, bully, or intimidate participants, volunteers or employees of Camp Fire Camp Toccoa will not be allowed to participate in future or additional Camp Fire programs. Behaviors that constitute harassment and bullying include, but are not limited to, comments that are derogatory with respect to race, religion, gender, sexual orientation, color, or disability; sexually suggestive, humiliating, or demeaning comments; and threats to stalk, haze or physically injure another person.
- Possession of any of the following could result in immediate dismissal from Camp Fire programs: drugs, alcohols, tobacco, firearms, explosives, knifes or any other weapon.
